		ACTION
	The Chairman welcomed all and reminded them that the meeting is not being recorded, anyone wishing to record the meeting must declare this in advance.	
1	OPEN FORUM	
	Prior to the start of the meeting an Open Forum was held.	
	Mrs Hutson confirmed that development land on Chapel Road has been sold by Benacre Company. Mrs Hutson met with 3 prospective developers, Cripps were a clear favourite & the sale has now completed. The Chairman explained the PCs role in the planning process and said that comments & concerns from tonight's meeting will be published on the PC website and updated as responses are received from the developer.	
	Mr Marc Nolan of Chaplin Farrant Architects spoke on behalf of the developers, he said Cripps Developers are a Beccles based company with a track record of providing high quality homes, they are keen to work with the local community and take all views on board. Site plans were shared and discussed. The proposal is for 65 dwellings with approximately half being single storey to minimise the impact on surrounding countryside & dwellings. There will be 18 affordable homes, primarily single storey. A new attenuation pond is included to alleviate flooding and create an environmentally friendly wetland habitat. A fully equipped play area is included in the scheme along with footpaths to encourage dog walkers etc. Archaeological work is due to begin next week. It is anticipated the total build time of the site will be 2 years. There will be a further consultation event, hopefully face to face.	
	The Chairman invited members of public to speak and raise any questions with Mr Nolan.	
	Valerie Barber spoke re the 'ransom strip', she said it is a lovely area and supports lots of wildlife, she would like to see it remain along with the fence on the field side of it. Mr Nolan said there are no plans to change this.	
	Valerie Barber spoke re surface water and concerns that this may increase, Mr Nolan said the new attenuation pond is in addition to the existing one & designed to prevent flooding. The Environment Agency will be consulted and need to approve the work.	
	Valerie Barber said originally 60 dwellings were proposed – this has now risen to 65 which means less space and more cars. Mr Nolan said there are more dwellings, however a greater percentage are bungalows and because	

of this he estimates there will potentially be less cars than if 60 houses were built.

Valerie Barber said the footpath shown on the plans is not currently well used, residents tend to walk along the side of the ransom strip to the A12. Mr Nolan said there is potential to extend the footpath to the A12 and he will look into this.

Greg & Joni Tallamy spoke, they live in Priory Road, their orangery and dormer windows overlook the entire site, they are very concerned that the 2 storey buildings in the centre of the site will overlook their garden. There were diggers on site today and 8 workmen looking into their garden. The headlights of cars driving down the new roads on site will shine directly into properties on Priory Road. They would like to see a screen of established trees. Mr Nolan said he will visit the site to review this.

Greg & Joni Tallamy feel the footpath along the outer edge of the site imposes on houses along Priory Road. Mr Nolan said the potential for this to be relocated will be explored.

Greg & Joni Tallamy spoke re flooding – the stream is currently cleared by the Environment Agency twice a year – they fear any excess water will flood and impact on Priory Road residents. Mr Nolan said water will not be allowed to run off site, there will be control mechanisms. Mr Nolan advised that the first part of any build is drainage and foundations – Cripps maintain clean and tidy sites – roadways go in very early to minimise mud/surface water. Mr Nolan will speak with the Engineers and provide further detail.

Keith & Rita Perry – echo concerns raised – they spoke re the sewage which is currently pumped to near Pyes Hall – can the system cope? Mr Nolan said Anglian Water will be statutory consultees, they have confirmed that there is spare capacity, at peak times waste can be stored on site and pumped out at quieter times, this will be managed.

Rita Perry expressed concern the safety of the pond, especially to children. Mr Nolan said, unlike the original pond, the new pond will be larger and shallower, with gently sloping sides, for much of the time it will be very shallow or even empty. He anticipates the pond will enhance the area rather than detract from it. It will be designed with safety in mind. Keith Perry asked if the area would be maintenance free – Mr Nolan said all open space on site will be managed through a maintenance company & be paid for by residents. Roads will be maintained by Highways and drainage by Anglian Water.

John Stammers of Priory Road spoke re flooding – this year there has been more flood water than in the last 20 years & at its peak was approx 2 feet deep. He believes the attenuation pond is higher than the land which floods. Mr Nolan said he understands concern however the Environment Agency will not permit any work which will add to the flooding. Mr Nolan is happy to visit individual properties and discuss concerns.

Fiona Anderson of Chatten Close echoed concerns – she said the footpath from Chapel Road around the field follows the buffer zone to the High Street and she would like to see this remain. Mr Nolan said Secure by Design (Police) advice does not encourage footpaths that are between properties or not overlooked but he would certainly look into extending the path to the A12.

Fiona Anderson spoke re the pond and said children can drown even in shallow water – she would like to see the safety of the pond reviewed.

Fiona Anderson spoke re traffic on Chapel Road – the school bus currently stops almost opposite the site entrance. Mr Nolan said currently it is National Speed limit from the West and he would welcome a reduction. He will look at the possibility of a layby being created which could accommodate the school bus and be used as additional parking outside school hours. He will also work with Highways to look to introduce a safe pedestrian crossing. The Clerk said there are already issues on this road as it is used by lorries to cut through to the A12 rather than go along Guildhall Lane, Mr Nolan will discuss this with Highways.

Simon Brimacombe spoke re the ransom strip – this has previously been maintained by Benacre Company – Mr Nolan will look into this and advise.

Simon Brimacombe said single storey dwellings are being built to minimise visual impact yet his house on Chatten Close will now face houses which will result in a loss of light/view. Mr Nolan said there will be a minimum of 30m between the properties but he will review.

Simon Brimacombe spoke re the number of new dwellings – 65 could lead to 130+ vehicles coming and going, the junction of Chapel Road & A12 is already busy. Dentists and Doctors are already in short supply and this development will lead to greater demand. Mr Nolan said there is little that can be done to improve the Chapel Road/A12 junction. ESC will have consulted with health care providers as part of the Local Plan process.

Simon Brimacombe asked if the entrance to the site and approach roads will be kept clean during the build. Mr Nolan said wheel washing is likely to be a condition of planning & the site will be very well managed.

Chris Mead said he was surprised by the low proportion of affordable housing. Mr Nolan said ESC guidance is for 25% therefore 18 out of 65 is acceptable.

Chris Mead said if thermal efficient houses are being built, has ground or air source heating been considered. Mr Nolan said all options are considered – 20% of energy has to be generated on-site.

Claudia Osborne said her concerns have already been addressed – her main concern is that the attenuation pond appears to be higher than the houses on Priory Road.

The Chairman asked that priority for affordable housing be given to local people. Mr Nolan said this is managed by ESC and he will liaise with the Housing Officer to ask that priority be given to people with a local connection.

The Chairman thanked all for their input & said it had been good to have been able to hold constructive conversations at this early stage in order to work towards the best outcomes for all.

Mr Nolan thanked everyone for a positive session. He will feedback via the Clerk and advise asap re further consultation opportunities.
