Proposed by Mrs Angela Day, seconded by Mrs Barbara Buckingham was carried unanimously



WRENTHAM VILLAGE MANAGEMENT COMMITTEE

Resolution to amend the Governing Document of Wrentham Village Hall of the present Trustees and Management Committee to the Sole Trusteeship of Wrentham Parish Council. 11th March 2010

"That under the powers given to them under Section 74D of the Charities Act 2006 and under clause 17 of the Scheme dated 28th June 1963 made by the Minister of Education (as amended by a Scheme dated 8th November 1984 and an Authority dated 14th March 1985 both made by the Charity Commission) and being the Governing document ("the Governing Document") relating to the Charity known as Wrentham Village Hall (registered Charity number 304844) the Committee of Management and Trustees of Wrentham Village Hall hereby make the following amendments to the provision of the Governing Document:

- (1) That having regard to the difficulties experienced in obtaining new members to serve on the Committee of Management as provided by Clause 3 of the Governing Document (whether they be elected, representative or co-optative) the Committee of Management shall henceforth consist of Wrentham Parish Council and its members for the time being and from time to time who shall have power to co-opt or elect such other persons to serve on the Committee of Management and for such length of time as shall in the sole discretion of the Parish Council be deemed advisable and whether such other persons are nominated by or be representative of any organisation in the Parish of Wrentham as provided in Clause 4 of the Governing Document or independent of any such organisation.
- (2) That the freehold property consisting of the land described in two Conveyances both dated 10th July 1985 one made between Sir Richard John Sherlock Gooch and the Trustees of Wrentham Village Hall and the other made between Adnams & Company plc and the said Trustees together with the building known as Wrentham Village Hall and together with all stocks, shares, funds and securities at present vested in the names of custodians trustees or held by the Committee of Management (the same having never been vested in or transferred to the Official Custodian for Charities as contemplated by Clause 19 of the Governing Document) shall forthwith be vested in or transferred to Wrentham Parish Council (a corporate body) as sole Trustee of the Wrentham Village Hall Charity.
- (3) That the Governing Document shall henceforth be construed as if reference to the Minister of Education were references to the Charity Commission
- (4) That apart from the above-mentioned amendments the object, provisions, rules and regulations contained and set forth in the Governing document remain unchanged.

Dear Mr Reeves

Thank you for your letter and enclosures received 19 March regarding an amendment to the governing scheme of the above charity. I have today recorded on the Register that the trustees have affected an amendment. It may however take up to five working days for this update to take effect on our website.

This is on the understanding that the Parish Council understand that as sole trustee it must run the Charity in accordance with the original trusts. When acting as the Charity Trustee they must act in the best interest of the charity and not in furtherance of any council policy that is counter to the charity's interest. The charity's property remains charitable assets and does not form part of the Council's corporate property.

To enable us to update the correspondent details and remove the details of the present trustees we need the full correspondence address of the Parish Council or replacement contact details. A currently listed trustee could do this by phone as long as they are ringing from a phone number we can verify as one we have recorded on their trustee details, alternatively the present listed correspondent could amend these details on line

Charity trustees have a legal obligation, under Section 3(7) of the Charities Act 1993, to keep us informed of any changes to this register entry or to their charity's trusts, and supply us with details of the change.

The Central Register of Charities is open to the public and the Charity's governing documents and documents effecting changes to those governing documents are open to public scrutiny. Therefore it is important for both the donors and the beneficiaries that details are kept up to date
